

New Home Offer

Terms and Conditions

- 1. This promotion is applicable for any new resident who:
 - a) signs an application to purchase an occupation right at a participating Australian Ryman village for a qualifying apartment or villa (qualifying unit) within the period commencing 12.00am, 6 November 2024 and ending 11.59pm, 20 December 2024 (Promotional Period);
 - b) enters into a Residence and Management Contract in Ryman's standard form; and
 - c) settles the purchase of the qualifying unit on the later of:
 - (i) within 120 days of signing the application in respect of the qualifying unit; or
 - (ii) within 30 days after completion of construction of the qualifying unit (where construction of the qualifying unit is not complete as at the date of the application) or that refurbishment of the qualifying unit is complete (where the qualifying unit will be refurbished before the new resident is required to settle the purchase of the qualifying unit).
- 2. Subject to clause 1, the purchaser(s) shall receive a credit of \$20,000 on settlement (**Promotion**). The credit will be applied as a suspended contribution, which will have the effect of reducing the amount to be paid by the purchaser on settlement by \$20,000.
